

What are the best practises for decorations Additik™ repositionable?

The Additik™ repositionable decorations are dedicated to furniture IKEA™. They are already cut in the standard dimensions of doors, trays, drawers of furniture... IKEA™, and made with an adhesive repositionable, to facilitate their installation.

They must be put on plane support, clean, smooth, appropriate, dry and healthy surfaces.

Additik™ decorations stick and unstick so easily, on condition naturally to respect the advice of installation above.

Decorations are covered with a protective film, you can clean them with a sponge (do not use abrasive sponge).

Posters Additik™ is conceived for glass doors, and glazed trays. They are already cut in the standard dimensions of doors and trays of furniture IKEA™ to facilitate their installation.

To contribute to the environmental protection, we selected a paper post benefiting from Eco-certificate (made in France in an ISO-certified factory 14001 and a certified paper pulp FSC).

Our posters are also printed from more ecological aqueous ink.

Posters Additik™ is paper, it is thus preferable not to wet them.

I've got furniture but not from IKEA ™, could I use your repositionable decorations on them?

Our decorations are specially conceived for furniture IKEA ™, in the dimensions of trays, doors, drawers of these last ones and it to facilitate their installation. It is up to you to use the adhesive decorations on the other furniture. We advise you however to respect the best practises.

How could I return you a product?

If you don't satisfied by a product, you can return it to Additik™. However, you have first to inform Additik™ in 7 working days after reception. The product shall be returned in its original packaging and the return costs will be in charge of customer. The refund will correspond only to the cost of one or several products.

Return Conditions :

- The product must be verified from its reception. Any wish of return must be communicated to Additik™ by mail for a maximum delay of 7 days as from the date of reception.
- The used products will be neither taken back, nor exchanged.
- Products have to be returned in their original packaging.
- Products must be returned to a single box, or with a packaging equivalent to the original box if this last one is unusable.
- Product must be returned with the delivery order
